Local merchants are encouraged to participate at the farmers' market at no cost. This is for community awareness of what Burlington has to offer, and promotional purposes only. All market day activities must be pre-approved by the Market Management. Applications must be received at least two weeks in advance of the date(s) you wish to attend. You will be notified when approved.

Promotional, sales in stores and event displays are allowed. No product sales. Local Merchants generally can sell raffle and event tickets. Anything planning to be sold must be described in the application and the Market Management will make a decision as to whether it is allowed.



All Vendor Guidelines must be complied with.



All local merchants will be set up in designated area.



Political/religious messages are not allowed at this market.



The merchant must provide their own tables, chairs and any other supplies, signage and equipment needed. Tents are not required but suggested.
